SANTOS. ALVIN EUGENE – RCP 18585

Convicted of burglary in the second degree and committed a dishonest or corrupt act by providing incomplete and misleading information regarding said conviction. Pursuant to a Decision proposed by an Administrative Law Judge, license revoked effective April 19, 2019.

BURTON, PATTI VAREE - RCP 5741

Prior surrendered license for being under the influence of alcohol while in the workplace. Pursuant to a Decision proposed by an Administrative Law Judge on a Petition for Reinstatement of a Revoked License, license reinstated, revoked, stayed, and placed on three (3) years' probation effective April 23, 2019. CARMICHAEL, ROMMIE GAIL – RCP 35659

Convicted of driving under the influence of alcohol with prior convictions for driving under the influence of alcohol and reckless driving involving alcohol. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective April 26, 2019.

CHAO, JOHN - RCP 38511

Failed to comply with Board-ordered probation by failing to abstain from the use of mood altering substances by testing positive for alcohol, failing to maintain daily contact with a Board-approved lab, failing to notify his employer of his probationary license status, and failing to pay probation monitoring fees. Pursuant to a Decision proposed by an Administrate Law Judge, license revoked effective May 3, 2019.

MOEN, STEPHANIE JEAN – RCP 17980

Worked in a healthcare profession or environment while under the influence of alcohol. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on five (5) years' probation effective May 6, 2019.

EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

Effective date of decision: The date the disciplinary decision goes into operation.

Default Decision: A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order: An order for discipline adopted by the Board.

Probation: Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, **Stayed**: "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

Stipulated Settlement: A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

RIVERA, MARIXA - RCP 18656

Prior surrendered license for failing to follow a physician's order to obtain an arterial blood gas, failing to perform a full assessment of respiratory status before and after performing respiratory treatment, falsely charting a patient was not in the hospital room when in fact they were, and falsely charting breath sounds for a patient she had not in fact assessed. Pursuant to a Decision

proposed by an Administrative Law Judge on a Petition for Reinstatement of a Surrendered License, license reinstated, revoked, stayed, and placed on three (3) years' probation effective May 14, 2019.

THOM. ERIK S - RCP 21788

Ability to practice as a respiratory care therapist safely is impaired due to mental or physical illness affecting competency. Pursuant to a Stipulated Surrender of License and Order, license surrendered effective May 25, 2019. **View Documents**

WARREN, SHAWNEE LEE - RCP 29830

Committed acts of unprofessional conduct by failing to accurately and timely document the care provided to a patient. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years' probation effective May 30, 2019. **View Documents**

LOBO. GINA MARIE - RCP 19798

Obtained Albuterol, a dangerous drug, without a physician's order and self-administered the medication using hospital equipment and without authorization. Pursuant to a Default Decision and Order, license revoked effective May 31, 2019. **View Documents**

BERGMANN, JASON M - RCP 22968

Convicted of taking a vehicle without consent and grand theft, arrested for possession of a controlled substance on two separate occasions, convicted of domestic violence, and convicted of violating a protective order with prior convictions involving drugs and theft. Pursuant to a Stipulated Surrender of License and Order, license surrendered effective June 14, 2019. **View Documents**

ROBLES, STACY RENE - RCP 30545

Convicted of elder abuse and arrested for public intoxication with a prior conviction for vandalism and a prior arrest for possession of a controlled substance. Pursuant to a Default Decision and Order, license revoked effective June 28, 2019. **View Documents**
