Committed acts of negligence and unprofessional conduct in his care of a patient by administering medication to a patient via a peripheral IV line and administering medication to a patient by a means other than inhalation. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on two (2) years' probation effective July 13, 2017. View Documents

Convicted of driving under the influence of alcohol with a prior arrest for disorderly conduct while under the influence of alcohol. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective July 13, 2017. View Documents

## EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

**Effective date of decision:** The date the disciplinary decision goes into operation.

**Default Decision:** A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order: An order for discipline adopted by the Board.

**Probation:** Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

**Revoked, Stayed:** "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

**Stipulated Settlement:** A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

Convicted of unlawful sexual intercourse with a minor and accessory after the fact. Pursuant to a Stipulated Surrender of License and Order, license surrendered effective August 5, 2017. View Documents
