### **BURDICK, JONATHAN D - RCP 37289**

Convicted of being an accessory after the fact, a felony. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on five (5) years' probation effective July 15, 2019.

### **GUILIN, ALICE CECELIA - RCP 11406**

Failed to comply with Board-ordered probation by failing to abstain from the use of mood-altering substances by testing positive, on two (2) separate occasions for metabolites of alcohol. Pursuant to a Stipulated Surrender of License and Order, license surrendered effective July 25, 2019.

### CHILDRESS, ROBERT LEE - RCP 34104

Committed acts of negligence; fraudulent, dishonest or corrupt acts; falsifying patient records; and unprofessional conduct in that he spent insufficient time with five patients and falsified medical records. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years' probation effective August 5, 2019. View Documents

### AKA. AYLIN - RCP 26837

Committed acts of negligence; falsifying or making grossly incorrect, inconsistent, or unintelligible entries into any patient, hospital or other record; and unprofessional conduct in the treatment of two patients. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective August 26, 2019.

## O'DETT, RONALD BRADLEY - RCP 34800

Committed acts of possession, use, or administration to oneself, of any controlled substance or dangerous drug; and unprofessional conduct in that he tested positive for amphetamines, methamphetamine, MDA, MDMA. Pursuant to a Decision proposed by an Administrate Law Judge, license revoked, stayed, and placed on two (2) years' probation effective August 27, 2019.

## EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

**Effective date of decision:** The date the disciplinary decision goes into operation.

**Default Decision:** A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

**Disciplinary Order:** An order for discipline adopted by the Board.

**Probation:** Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, Stayed: "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

**Stipulated Settlement:** A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

### SABO, LIVIU – RCP 19368

Convicted of resisting, delaying, and obstructing a peace officer and use of alcoholic beverages to an extent or in a manner dangerous or injurious to himself or others. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective August 29, 2019.

# DISCIPLINARY ACTIONS July 1, 2019 – September 30, 2019

### FRICK, MICHAEL - RCP 24382

Committed acts of negligence, unprofessional conduct, knowingly providing false statements or information to the Board during an investigation, and making grossly incorrect or inconsistent entries in patient's chart by failing to thoroughly assess a patient's overall medical condition and/or artificial airway condition prior to changing the tracheostomy tube, failing to evaluate the prevention of adverse reactions or possible complications, failing to have another qualified medical professional in the room to assist with replacing the patient's tracheostomy tube, failing to have all necessary equipment and supplies readily available in case of an emergent situation, failing to notify the physician regarding the complications occurring after the tracheostomy tube change, and failing to adequately and timely evaluate and provide emergent clinical interventions to facilitate the need for an alternative means of resuscitation after decannulation. Pursuant to a Stipulated Surrender of License and Order, license surrendered effective September 1, 2019.

#### PHILLIPS. SHERI K. - RCP 37217

Convicted of driving under the influence of alcohol and admitted the enhancement for driving with a blood alcohol content of 0.20% or more. Previously arrested for child endangerment and drunk in public. Pursuant to a Stipulated Surrender of License and Order, license surrendered effective September 20, 2019.
