SANVICENTE, JORDAN KYLE – RCP 36332

Convicted of reckless driving involving alcohol and perjured license renewal application by failing to disclose the conviction. Previously convicted of driving under the influence of alcohol with a blood alcohol content of .08% or more as well as theft. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective October 10, 2019. View Documents

BRAVO, CHRISTOPHER - RCP 18118

Convicted of driving under the influence of alcohol with a blood alcohol content of .08% or more and admitted to a probation violation. Perjured two separate license renewal applications by failing to disclose an arrest on the first renewal and a conviction and another arrest on the second renewal. Pursuant to a Default Decision and Order, license revoked effective October 16, 2019.

MALI. KATHRINE ANN – RCP 12771

Failed to comply with Board-ordered probation by failing to provide proof of additional continuing education, failing to maintain a valid license, failing to timely pay probation monitoring costs and cost recovery. Pursuant to a Default Decision and Order, license revoked effective October 30, 2019.

JOSE, MARC IAN - RCP 36995

Convicted of driving under the influence of alcohol with a prior conviction of reckless driving involving alcohol. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on two (2) years' probation effective November 2, 2019. View Documents

RUTLEDGE, KIMBERLEE A. – RCP 29646

Committed acts of negligence and unprofessional conduct by failing to perform a timed ABG for a critical ICU patient as well as leaving the hospital during her shift without communicating the timed ABG order to a respiratory care therapist co-worker. Two previous convictions of driving under the influence of alcohol. Pursuant to a Default Decision and Order, license revoked effective November 8, 2019.

EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

Effective date of decision: The date the disciplinary decision goes into operation.

Default Decision: A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order: An order for discipline adopted by the Board.

Probation: Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, Stayed: "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

Stipulated Settlement: A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

KIM, JANE YOUNG - RCP 25774

Failed to comply with Board-ordered probation by failing to abstain from the use of a mood-altering substance, to wit, methamphetamine. Pursuant to a Default Decision and Order, license revoked effective November 13, 2019.

CAMONAYAN, REDEN MERIS – RCP 14031

Prior revoked license based on two convictions: 1) making terrorist threats, and 2) vehicular manslaughter and failing to stop at the scene of an injury accident. Pursuant to a Proposed Decision on a Petition for Reinstatement of a Revoked License, Respondent's license was reinstated, immediately revoked, stayed, and placed on three (3) years' probation effective November 15, 2019.

KOLOMIYETS, LILIYA P. – RCP 37767

Committed negligence and unprofessional in the care and treatment of two patients by failing to make necessary changes to a patient's ventilator settings to correct respiratory acidosis, failed to contact an attending physician to discuss ventilator settings and/or continuous mechanical ventilation, and failed to ensure sufficient oxygen flow to a manual resuscitator, even after being directed to increase the oxygen flow. Pursuant to a Proposed Decision and Order, license revoked, stayed, and placed on three (3) years' probation effective December 20, 2019.
