SANGHERA, MUNPREET KAUR – RCP 31801

Multiple convictions of driving under the influence of alcohol with blood alcohol contents of 0.15% or more and 0.20% or more. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years' probation effective May 10, 2024.

SALDANA, ROBERTO R. – RCP 17302

Prior revoked license based on working as a respiratory care practitioner while under the influence of alcohol, unprofessional conduct, and falsifying or making a grossly incorrect or inconsistent entry in a hospital record in 2011. Pursuant to a Proposed Decision by an Administrative Law Judge, reinstatement of license granted, license immediately revoked, stayed, and placed on three (3) years' probation effective May 27, 2024.

CAMIRAND, JEFFERY E. – RCP 40043

Committed unprofessional conduct when working in a health care profession and environment while under the influence of alcohol that was consumed and possessed at work. Knowingly provided false statements to a Board Investigator when questioned. Pursuant to a Default Decision and Order, license revoked effective May 29, 2024.

GUERRERO, JOSHUA I. – RCP 41329

Committed a fraudulent, dishonest, and corrupt act, falsified records, and engaged in unprofessional conduct in that he falsified documents to gain employment. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective May 31, 2024.

EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

Effective date of decision: The date the disciplinary decision goes into operation.

Default Decision: A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order: An order for discipline adopted by the Board.

Probation: Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, Stayed: "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

Stipulated Settlement: A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

ISON, STEPHANIE KRISTEN – RCP 36163

Tested positive for cocaine as the result of a court-ordered drug test. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective June 10, 2024.

Convicted of public intoxication of alcohol, with a prior arrest for child endangerment and public intoxication. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective June 10, 2024.
