DIZON, JOSHUA - RCP 40618

Committed fraudulent acts, falsification of records, and unprofessional conduct by falsifying his timesheets and forging the approver's signatures on said timesheets, claiming he worked hours at a medical facility when in fact he did not. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years probation effective January 6, 2024. View Documents

KHABEER, RIYADH HASAN - RCP 39959

Committed fraudulent acts, falsification of records, and unprofessional conduct by falsifying his timesheets claiming he worked hours at a medical facility when in fact he did not. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years probation effective January 29, 2024. View Documents

BEENER, SEAN ERIC - RCP 34157

Committed negligence and unprofessional conduct in his care and treatment of multiple patients by failing to properly set up and administer breathing treatments, as well as sufficiently and accurately document patients' breathing treatments. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years probation effective February 8, 2024.

MOURADYAN, SUREN - RCP 24896

Convicted of vehicular manslaughter with gross negligence, commission of an act of endangerment involving persons under 18 years of age, and failure to comply with a court order. Pursuant to a Default Decision and Order, license revoked effective February 21, 2024.

EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

Effective date of decision: The date the disciplinary decision goes into operation.

Default Decision: A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order: An order for discipline adopted by the Board.

Probation: Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, Stayed: "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

Stipulated Settlement: A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

HERNANDEZ, LOURDES - RCP 43160

Convicted of driving under the influence of alcohol with a blood alcohol content of 0.08% or more and child endangerment. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years probation effective February 22, 2024.

BURCIAGA, ARMANDO - RCP 31901

Convicted of possession for sale of controlled substances (fentanyl and cocaine) with an operable firearm and possession/sale/transport/offer to sell fentanyl. Pursuant to a Default Decision and Order, license revoked effective February 29, 2024.

ZARAGOZA, RICARDO – RCP 37328

Convicted of driving under the influence of alcohol with a blood alcohol content over 0.08% causing bodily injury and hit and run causing injury. Subsequently, convicted of another driving under the influence of alcohol offense with admittance to the prior conviction. Additionally, used a controlled substance, cocaine, in violation of law and to an extent or in a manner dangerous to himself or others. Pursuant to a Default Decision and Order, license revoked effective February 29, 2024.

Committed negligence, unprofessional conduct, and fraudulent, dishonest, or corrupt acts by falsely documenting medical records of multiple patients. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years probation effective March 1, 2024. View Documents

KRAUSE, CHRISTOPHER JAMES - RCP 26464

Convicted of driving under the influence of alcohol with a blood alcohol content of 0.08% or more with disciplinary considerations for two prior offenses and prior disciplinary action against the license. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years probation effective March 14, 2024.

JENSEN, AARON DANIEL - RCP 41190

Convicted of an alcohol-related driving offense and was ordered to complete a diversion program for another alcohol-related driving offense.

Additionally, used alcohol to an extent or in a manner dangerous to himself or others. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on 35 months probation effective March 29, 2024.
