LANCASTER, JAMES AMOS - RCP 36960

Failed to comply with terms and conditions of probation, when testing positive for cocaine metabolite. Pursuant to a Stipulated Surrender of License and Disciplinary Order, license surrendered effective July 25, 2024.

CHACON, ADELINA CRISTINE - RCP 40811

Convicted of possession of a controlled substance and giving false information to a police officer, and in another incident, convicted of taking a vehicle without owner consent and resisting arrest. Discipline considerations included a prior conviction for possession of a controlled substance. Pursuant to a Default Decision and Order, license revoked effective July 27, 2024.

PHOUANGPHET, SUDAWAN - RCP 37022

Committed negligence, administered unsafe respiratory care, and falsified or made grossly incorrect or inconsistent or unintelligible entries when documenting medications provided to several patients. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective August 3, 2024.

HAWKINS, MARCEL JAVON - RCP 41421

Committed a fraudulent, dishonest, or corrupt act, falsified records, and engaged in unprofessional conduct by submitting falsified timecards, which resulted in an overpayment. Pursuant to a Stipulated Surrender of License and Disciplinary Order, license surrendered effective August 19, 2024.

WILSON, MARK O. - RCP 22708

Committed negligence, unsafe respiratory care, falsification of medical records, and unprofessional conduct in the care and treatment of multiple patients. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years' probation effective August 22, 2024.

EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

Effective date of decision: The date the disciplinary decision goes into operation.

Default Decision: A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order: An order for discipline adopted by the Board.

Probation: Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, Stayed: "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

Stipulated Settlement: A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

SCHUBERT, SAMANATHA M. - RCP 41127

Convicted of driving under the influence of drugs causing bodily injury. Pursuant to a Default Decision and Order, license revoked effective August 29, 2024. **View Documents**

JACKSON, LATANA - RCP 44984

Committed a fraudulent, dishonest, or corrupt act, falsified records, and engaged in unprofessional conduct by submitting falsified timecards, which resulted in an overpayment. Pursuant to a Default Decision and Order, license revoked effective September 19, 2024.
