VARGAS, PATRICK VALENTE – RCP 41097

On two occasions, convicted of driving under the influence of alcohol and failed to disclose his arrests and convictions on his license renewal application. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years' probation effective July 3, 2025.

LIE, SADIE LEE – RCP 25970

Convicted of driving under the influence of alcohol with a blood alcohol content of 0.08% or more and failed to disclose her conviction on her license renewal application. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective August 15, 2025.

YOUNGBLOOD, SHANNON – RCP 26970

Committed negligence, unprofessional conduct, and administered unsafe respiratory care procedures when she failed to carry out a physician's orders. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective August 15, 2025.

SUACILLO, JENNIFER – RCP 46401

Convicted of driving under the influence of alcohol with a blood alcohol content of 0.08% or higher. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective August 15, 2025.

JARANILLA, THERESE – RCP 41398

Convicted of driving under the influence of alcohol with a blood alcohol content of 0.08% or higher. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective August 23, 2025.

EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

Effective date of decision: The date the disciplinary decision goes into operation.

Default Decision: A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order: An order for discipline adopted by the Board.

Probation: Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, Stayed: "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

Stipulated Settlement: A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

DACAYO, LORI ELIZABETH – RCP 18126

Violated terms and conditions of probation, committed negligence, a pattern of substandard care, and administered unsafe respiratory care procedures when she failed to deflate a patient's tracheostomy tube cuff, failed to document that she changed a ventilator setting, and failed to wear a PPE gown. Committed unprofessional conduct when she refused a patient's relative's request to place the PMV valve on a patient, despite a physician's order and failed to de-escalate a verbal confrontation with a patient's relative. Pursuant to a Stipulated Surrender of License and Disciplinary Order, license surrendered effective September 8, 2025.
