



DISCIPLINARY ACTIONS

October 1, 2024 – December 31, 2024

GREEN, DAMIKA – RCP 44586

Committed a fraudulent, dishonest, and corrupt act, falsified records, and engaged in unprofessional conduct by submitting falsified timecards, which resulted in an overpayment. Pursuant to a Default Decision and Order, license revoked effective October 4, 2024.

LOBO, GINA MARIE – RCP 19798

Prior revoked license based on self-administering a dangerous drug without a physician's order, falsifying medical records related to the self-administration of the dangerous drug, committing a fraudulent, dishonest, or corrupt act, falsifying statements to the Board, negligence, and unprofessional conduct in 2018. Pursuant to a Proposed Decision by an Administrative Law Judge, reinstatement of license granted, license immediately revoked, stayed, and placed on three (3) years' probation effective October 29, 2024.

WYCOCO, ROSE P. – RCP 28416

Committed negligence and administered unsafe respiratory care while suctioning a patient. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective November 1, 2024.

BOWEN, DILLION JACOB – RCP 41735

Committed negligence, falsified or made grossly incorrect entries in a patient record, committed a fraudulent, dishonest, or corrupt act, and committed unprofessional conduct in that he falsified medical records by making entries into six different patient records documenting services that he did not, in fact, perform. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years' probation effective December 5, 2024.

EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

Effective date of decision: The date the disciplinary decision goes into operation.

Default Decision: A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order: An order for discipline adopted by the Board.

Probation: Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, Stayed: "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

Stipulated Settlement: A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

MARTINEZ, ARTURO ISAAC – RCP 36932

Committed corrupt acts, unprofessional conduct, and falsified or made grossly incorrect entries in patient records when he engaged in sexual misconduct toward a patient and failed to include clinically significant events in the patient/hospital records for two patients. Pursuant to a Proposed Decision by an Administrative Law Judge, license revoked effective December 24, 2024.
